The Board of studies of B.Com Computer Applications of Sri RamaKrishna Mission Vidyalaya college of Arts and Science (Autonomous, Reaccredited by NAAC with 'A' grade) Coimbatore-20 met at 10.00 a.m on 28.10.2017 in the Un-aided seminar hall.

The Following matters were discussed in the Board meeting:

1. A workshop for 3rd year Commerce CA students has to be conducted on the topic GST by the external experts in the field.
2. Slight revision has to be made in the principles of accounting (13UCC1C0C) in the first semester for the students admitted from 2018-2019 onwards.
3. Slight revision has to be made in the financial accounting (13UCC2C02) course in the second semester for the students admitted from 2018-2019 onwards.
4. Indirect taxation including GST course has to be introduced with retrospective effect due to the introduction of GST by the Central Government for the students admitted from 2016-2017 onwards.

The following things were decided in the board:

1. Faculty members of Commerce with Computer Applications has to involve in sharing their experience and teaching atleast one unit in the content of curriculum of the institution under mutual agreement with our college through the faculty exchange programme.
2. Certificate courses such as Tally ERP-9 & Office automation and Business accounting Executive are offered to our Department students with nominal cost by external experts in the field
3. **The board proposes to follow the Bharathiar university syllabus for B.Com Professional Accountancy course.**

There is no change in the syllabus for the students admitted from 2015-16 onwards. The owing changes proposed by the board will be implemented in the next board meeting for the students admitted from 2016-17, 2017-18 and 2018-19 onwards.

The Following decisions were made in the Board meeting:

1. The following revision was made in the syllabus of B.Com (CA) for the students admitted from 2016-17 & 2017-18.

Indirect tax (Including GST) course was introduced in the sixth semester as core 15th for the students admitted from 2016-17 & 2017-18 by removing E-Commerce course (core 15) from the syllabus. There is no change in the syllabus for the students of B.Com (CA) admitted from 2016-17 & 2017-18 apart from the above mentioned changes.

2. The board proposes the revised syllabus for first and second semester B.Com Computer applications course for the students admitted from 2018-19 onwards. Third, fourth, fifth and sixth semester syllabus for the students admitted from 2018-19 will be decided in the next board meeting in order to adopt latest changes.

3. The board proposes the revised syllabus for first and second semester B.Com Professional Accountancy course for the students admitted from 2018-19 onwards. Third, fourth, fifth and sixth semester syllabus for the students admitted from 2018-19 will be decided on the next board meeting in order to adopt latest changes.

4. There is no change in the syllabus for the students of B.Com Professional Accounting admitted from 2017-18 onwards.

5. It has been decided to implement outcome based education for the students admitted from 2018-19 onwards.













6. The board authorises the chairman to make any changes in the syllabus according to the common college rules framed by the standing committee.
