

MINUTES OF THE BOARD OF STUDIES MEETING

The Board of Studies meeting of B.Com Professional accounting of Sri Ramakrishna Mission Vidyalaya College of Arts and Science (Autonomous, Reaccredited by NAAC with 'A' grade) Coimbatore-20 was conducted at 10.00 a.m on 22.02.2019 in the seminar hall, Un-aided wing.

The following topics were discussed in the Board meeting:

1. The board has to decide the specific outcomes of the programme.
2. The courses in the programme would help the students in skill development, enhancing employability and entrepreneurship skills have to be identified.
3. Syllabus for the third semester and fourth semester has to be framed with course learning objectives and course learning outcomes.
4. There were two auditing papers in the fifth semester and one auditing paper in the sixth semester. This may be reduced into two papers according to the need of the hour.
5. The computer practical papers in semester 3 and 4 may be enhanced or changed to enable the students to easily grasp the employment opportunities.
6. Non- Major Elective-II paper may be offered to other department students.
7. Non-Major elective –I paper may be changed in such a way that it improves the communication skills of the students.

The following things were decided in the board:

1. The programme specific outcomes were fixed.
2. The courses like MS-office (practical) in the first semester, Finance Analytics Using MS-Excel (practical) in third semester, Principles of Marketing in the third semester, Web Design Using HTML (practical) in the fourth semester, Banking and Insurance Law in the fifth semester and Cyber Law in the sixth semester were identified as developing skills among the learners.
3. The courses like Tally & Internet (practical) in the second semester, Executive Business Communication in the fourth semester and Project Work and Viva Voce in the sixth semester were identified as enhancing the employability of the learners.
4. The courses like Finance Analytics Using Ms-Excel (practical) in the third semester, Strategic Management in the third semester and Financial Management in the fifth semester will enable the learners to become entrepreneurs.
5. The syllabus of third semester and fourth semester was framed with course learning objectives and course learning outcomes.
6. The following changes were made in the syllabi of fifth and sixth semester for the students admitted from 2017-18 onwards:

a) In the fifth Semester Principles of Auditing (course III) was removed from the syllabus.

b) Direct Tax I (course IV) in the fifth semester having 75 marks, 3 credits and 5 hours is converted into course having 100 marks, 5 credits and 6 hours.

- c) Direct Tax II (Course V) in the fifth semester having 75 marks, 3 credits and 4 hours is converted into course having 100 marks, 4 credits and 5 hours.
- d) Advanced Accounting II (Course I) in the fifth semester having 100 marks, 4 credits and 5 hours is converted into course having 100 marks, 5 credits and 6 hours.
- e) Auditing and Assurance (Course II) in the fifth semester having 100 marks, 4 credits and 5 hours is converted into course having 100 marks 4 credits and 6 hours.
- f) Corporate Accounting (Course I) in the sixth semester having 4 credits is converted into course having 5 credits.

The following changes were made in the syllabi of third and fourth semester for the students admitted from 2018-19 onwards:

- a) Computer Application Practical-II- **ORACLE** (CORE-IX) in the third semester is replaced with Computer Application Practical-II-**FINANCE ANALYTICS USING MS-EXCEL**.
- b) Computer Application Practical-II- **OOPS & C++** (CORE-XIII) in the fourth semester is replaced with Computer Application practical-II- **WEB DESIGN USING HTML**.
- c) Non-Major Elective course-II **GENERAL AWARENESS** in the fourth semester is replaced with entrepreneurship development which was offered to other department students.
- d) Non-Major Elective course-I **Constitution of India** in the third semester was converted in to Grammar and communication.
- e) Extension activities like NSS/ Sports in the sixth semester had been moved to Fourth semester.
- f) Unit-4 Sale of goods act 1930, of Mercantile Law in the first semester has been replaced with contract of agency act.
- g) Law of supply was added in Unit -II of Managerial Economics course in the third semester.
- h) Standard Costing was added with Unit -V of Cost Accounting Course in the third semester.

8. The board decides to follow the syllabi according to the above mentioned changes and other courses in the syllabus apart from changed, remaining are the same as per the previous board meeting.
