

MINUTES OF THE BOARD OF STUDIES MEETING

The Board of Studies of B.Com Professional Accounting of Sri Ramakrishna Mission Vidyalaya College of Arts and Science (Autonomous, Reaccredited by NAAC with 'A' grade) Coimbatore-20 was conducted at 10.30 a.m. on 03.12.2020 in the seminar hall, Unaided wing.

The following topics were discussed in the Board Meeting:

1. For UG programmes, the maximum credit limit may be fixed from 140 to 150 and the maximum marks may be fixed from 3600 to 3900.
2. Environmental Studies & Value Education is to be offered as off calendar instructional courses, in the second & fourth semesters respectively with two credits each.
3. The revised programme objectives & programme specific objectives are to be passed.
4. The course content of all courses may be framed with 20 % of the self-study content. The students may learn that content through online sources.
5. Evaluation pattern compressing 50 marks – internal & 50 marks - external is to be passed for UG programmes.
6. The percentage of content modification of each course may be mentioned in the minutes.
7. The courses may be planned in the fourth semester for credit transfer.
8. Introducing a common course from the commerce stream in the third and fourth semester and students can select the faculty members for their subject. It is implemented in the third semester and based on that review; it may be continued in the fourth semester.

The following changes were made in the syllabi of first to sixth semester for the students admitted from 2020 -2021 onwards:

Newly Introduced Courses:-

1. Fundamentals of Accounting were introduced in the first semester.
2. Public Finance was introduced in the second semester.
3. Financial Markets and Institutions new course was introduced in the fifth semester.
4. Research Methodology was introduced in the sixth semester.

Revised Courses:-

1. Principles of Accountancy syllabus were revised in the first semester.
2. Mercantile Law course name was changed as Commercial Law and it was shifted from the first to the third semester with revised syllabus.
3. Financial Accounting and Computer Applications Practical-II (MS Access & Tally) syllabuses were revised in the second semester.
4. Industrial Law, Cost Accounting, Managerial Economics and Principles of Marketing syllabuses were revised in the third semester.
5. In the fourth semester Advanced Accounting –II was changed as Advanced Accounting and the syllabus was revised.

6. In the fourth semester Company Law course was changed as Company Law and Secretarial Practice with revised syllabus.
7. Principles of Management syllabus was revised in the fourth semester.
8. In the fifth semester, Auditing and Assurance – I & II was merged as Auditing and Assurance with a new revised syllabus.
9. Corporate Accounting, Direct Tax, Executive Business Communication and Banking and Insurance Law syllabuses were revised in the fifth semester.
10. Indirect Tax syllabus was revised.

Shifted Courses with Revised Syllabus:-

1. Executive Business Communication course was shifted from fourth to fifth semester with revised syllabus.
2. Financial Management was shifted from fifth to sixth semester with revised syllabus.

Shifted Courses without Revised Syllabus:-

1. Environmental Studies moved from first to second semester.
2. Value Education moved from second to fourth semester.
3. Strategic Management was shifted from the third to the sixth semester.

Course Name Changed:-

1. In the fifth semester, Direct Tax – I was changed as Direct Tax with revised syllabus.
2. Project Work and Viva Voce course name was changed as Internship/Industrial Training in the sixth semester.

Courses Removed:-

1. Direct Tax – II course was removed from the fifth semester.

No change in the Syllabus:-

In the following courses there is no change in the syllabus,

- Computer Applications Practical-I (MS OFFICE),
- Computer Applications Practical – III (Finance Analytics Using MS Excel),
- Management Accounting,
- Computer Applications Practical-IV (Web Design Using HTML),
- Entrepreneurship,
- Financial Management and
- Cyber Law.

The following things were decided in the board:

1. The board decides to follow the above mentioned information which is related to syllabus from the first semester to sixth semester for the students admitted from the year 2020-2021 onwards.
2. Commerce Streams of B.Com (PA), B.Com (CA) and B.Com has commonly decided to allot Vth unit as a 20 % self study content for all the courses through online resources.
3. The board empowers the chairman to make any changes if necessary.


