### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter "MOU") is entered in to on this the 17th day of March 2016 by and between

**Foundation for CSR @ Redington**, a trust formed under the Indian Trust Act 1882 and having its office at SPL Guindy House, 95 - Mount Road, Guindy, Chennai – 600 032, represented by its authorised representative Mr. M. Muthukumarasamy, Trustee (hereinafter referred to as First Party)

And

**RAMAKRISHNA MISSION**, a trust formed under the Indian Trust Act. 1882 and having its office at RAMAKRISHNA MISSION VIDYALAYA, COIMBATORE represented by its authorised representative SWAMI GARISHTHANANDA, SECRETARY, SRI RAMAKRISHNA MISSION VIDYALAYA COLLEGE OF ARTS AND SCIENCE (hereinafter referred to as Second Party)

The First Party is a Trust formed by Redington (India) Limited, the author of the trust and is engaged in fulfilling corporate social responsibilities as envisaged under the provisions of the Companies Act, 2013;

The Second Party is a social welfare organisation with a mission to enhance socio-economic status of village community through interventions in health, education, social welfare, and livelihood and extension services like employment generation and knowledge management;

**Whereas**, the First Party expressed its desire to associate with Second Party strategically to provide its support to rural people from the Second Party's premises at **Sri Ramakrishna Mission Vidyalaya College of Arts and Science, Coimbatore** more fully described under the schedule to this MOU (Premises) for which the Second Party agreed.

Based on the above mutual understanding, the parties enter into this MOU to set out their respective responsibilities as below;

**NOW, THEREFORE, BASED ON THE MUTUAL COVENANTS AGREED TO BETWEEN THE PARTIES THIS MOU WITNESSETH AS FOLLOWS;**

1. The Second Party shall provide adequate space in the premises situated at Sri Ramakrishna Mission Vidyalaya College of Arts and Science, Coimbatore, more fully described in the Schedule here under to and in favour of the First Party for performing its corporate social responsibilities and related activities.
2. The activities to be conducted in the premises shall be predominantly in the field of education to the needy people in the locality, such as imparting training programs,

sponsoring education for needy students, abandoned women/children, conducting talent and science fairs etc as detailed in Annexure –I enclosed herewith.

3. The First Party shall work together with the Second Party and extend these programs and facilities to the students/unemployed youths identified by the First Party and the inmates of the Second Party.
4. The First Party acknowledges the goodwill and reputation of the Second Party in the field of society and shall work in such a manner to enhance the goodwill and reputation of the Second Party and shall not indulge in any activities that may hamper the name of the Second Party.
5. The First Party shall bear the cost of the amenities and utilities availed in the premises by the First Party, such as electricity and telephone charges, compensation to the trainers and other common amenities if any, specifically amicably agreed in writing by both parties. Such payments shall be paid as per the invoice to be raised by the Second Party on a monthly basis, subject to deduction of tax and Service tax, as applicable. Wherever it is possible the first party will pay the expenses directly to the service providers and vendors.
6. The Second Party shall provide necessary guidance, support and assistance to the First Party to effectively perform the corporate social responsibilities of the First Party to those needy people including providing space, man power if required and other basic amenities such as water, power supply, retiring and rest room facilities etc.
7. First party will create the infrastructure by way of renovation, alteration, repairing and remodelling existing building and facilities wherever requires (very limited approach for any civil construction model); provide furniture, computers, other latest technology products such as Tablets, etc; engage staff for co-ordination wherever required; and impart training, tuition including educating special children through special educators, other office bearers in carrying out the CSR activities at the aforesaid premises.
8. As First party is required to carry out this as part of its project of CSR activities and report in its Annual Report, Second Party, by Signing this MOU, agrees to be part of Foundation activities including use of its name, other details for use in Annual Report, Social media, Foundation website and other media promotion activities. Either of the Parties shall not deem to be a representative or agent of the other Party and shall be independent parties for the purpose of this MOU.
9. First Party shall also assist Second Party in its endeavours of protecting environment, flora and fauna.
10. This MOU shall construe to be a binding contract between the parties in respect of the subject matter of the MOU and shall have legal enforceability. However, considering the purpose for which the parties entering this MOU, the parties mutually agree that neither party shall be entitled for any remuneration/compensation from the other under this MOU. If either of the parties

are unable to fulfil any conditions for any reasons under this contract neither of them will be liable for any compensation to the other. Also if the contract is terminated at any point of time for any valid reason neither of the parties are entitled for any legal claim or compensation to the other for the termination of the contract.

11. This MOU shall be effective from the date of last sign off and shall continue to be in force and effect for a period of 3 years (Three Years) initially from the effective date. Second Party will support First Party to conduct their CSR activities in the premises all the time without any interruption irrespective of any management or person change. In case of any wilful misconduct or unethical approach to disturb the Second Party by the First Party, Second Party explaining the reasons to the management of First Party in writing will mutually bring an end to the partnership.
12. This MOU shall be terminated by either of the parties as provided below after three years;
  - i) By First Party by providing 3 month notice to the Second Party or as mutually agreed between the parties during the initial period.
