





Majority of the faculty members felt that the proportionate weightage has been given to both theory and practical.







Majority of the faculty members felt that the proportionate weightage has been given to both theory and practical.


Need for instilling flexibility in curriculum:

Majority of the faculty members felt that the proportionate weightage has been given to both theory and practical.


Need for instilling flexibility in curriculum:
