- Computer Application Practical III Finance Analytics Using MS Excel course to be introduced in the Third Semester.
- Computer Application Practical IV OOPS C++ course in the Fourth Semester may be removed.
- Computer Application Practical IV Web Design Using HTML course to be introduced in the Fourth Semester.
- Non Major Elective I Constitution of India course in the Third Semester may be replaced with Grammar and Communication course.
- Non Major Elective II General Awareness course in the Fourth Semester may be replaced with Entrepreneurship Development course.
- Sale of goods act 1930 has to be replaced with Contract of agency act in Mercantile Law course.
- Law of Supply has to be added in Managerial Economics course.
- Standard Costing has to be added in Cost Accounting course.
